WHEN I TURNED ON THE IGNITION THE AIRBAG LIGHT CAME ON. I TOOK THE CAR TO HONDA AND THEY SAID THE COMPUTER COMPONENT IN THE AIR BAG SYSTEM WAS DEFECTIVE. IT WOULD COST \$600 TO \$800 DOLLARS TO REPAIR/REPLACE. I CONTACTED HONDA THREE TIMES AND THEY WOULD NOT REPAIR THE AIRBAG SYSTEM SAYING THAT ALL PARTS ON THE CAR WEAR OUT AND HAVE TO BE REPLACED AND THAT IS MY RESPONSIBILITY. I ARGUED THAT SOMETHING LIKE A SAFETY DEVICE IN STANDBY CONDITION COULD NOT WEAR OUT SINCE IT WAS NEVER USED. THEY PERSIST IN SAYING ALL PARTS OF A CAR WEAR OUT AND HAVE TO BE REPLACED. I NEED HELP.
