WHILE DRIVING IN EXTREMELY COLD WEATHER THE ACCELERATOR STUCK OPEN. (IN RESEARCHING ON THE INTERNET I FOUND VOLKSWAGEN RECALLED CARS IN CANADA FOR THIS PROBLEM. RECALL TR (CANADA ONLY).) THIS HAPPENED THIS WINTER - BELOW 10°F . IT IS AN EXTREMELY HAZARDOUS SITUATION IN TRAFFIC. I HAD TO PULL OFF THE ROAD AND TURN THE CAR OFF -- PUSHING THE CLUTCH IN CAUSED HIGH REV'S. IN ADDITION, THE VEHICLE WOULD NOT IDLE WHEN IT WAS BELOW 20°F PUSHING THE CLUTCH IN AT A STOP LIGHT WOULD CAUSE THE ENGINE TO QUIT. REPLACING THE IDLE STABILIZER VALVE HELPED THIS ISSUE - AFTER THE ISV I REMOVED FROM THE CAR SAT INSIDE FOR SEVERAL DAYS I PICKED IT UP TO MOVE IT AND A CLEAR LIQUID RAN OUT WHICH LOOKED A LOT LIKE WA
