REAR WINDOWS ROLL DOWN ONLY 1/2 WAY, AND NOT WIDE ENOUGH FOR ESCAPE. RANDY KING, SERVICE MANAGER FOR CRAWFORD COUNTY FORD, STATED THAT THEY HAD HAD MULTIPLE MYSTIQUES, SAME PROB. THEY DISCOUNTED ONLY 1/2 THE COST TO US. TOTAL SPENT TO DATE ON ALL 4 WINDOWS/2 CARS \$800. PROBLEM INDICATED BY RANDY KING WAS POSSIBLE DANGER OF NOT BEING ABLE TO ESCAPE CAR IN EVENT OF EMERGENCY.
