NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

WHILE TRAVELING AT VARIOUS SPEEDS (5 MPH - 75 MPH), THE ENGINE STALLS WITHOUT WARNING FOR APPROXIMATELY 5-10 SECONDS AND THEN EITHER RESUMES OPERATION ON ITS OWN, OR MUST BE RESTARTED WHILE COASTING IN NEUTRAL. SOMETIMES THE ENGINE WILL RESTART EASILY, BUT SOMETIMES IT TURNS OVER SEVERAL TIMES BEFORE RESTARTING. OBVIOUSLY THIS HAS CREATED SOME EXTREMELY DANGEROUS SITUATIONS FOR MYSELF AND MY FAMILY. LOSING POWER ASSISTED FUNCTIONS (STEERING, BRAKING) AT HIGH SPEEDS HAS LEFT ME WITH LITTLE CONTROL OF THE VEHICLE ON SEVERAL OCCASIONS. I HAVE HAD THIS PROBLEM INVESTIGATED TWICE AT A FORD DEALERSHIP BUT THEY HAVE BEEN UNABLE TO FIND A PROBLEM. THEY ALSO INSTALLED A FLIGHT RECC
