ALL 4 ALLOY WHEELS ON MY MISTUBISHI ECLIPSE GT HAVE BENT OVER THE LAST 8 MONTHS. I HAVE NOT HIT ANYTHING TO CAUSE THESE FAILURES. I REPLACED ONE I OCTOBER 2001, ONE IN FEBRUARY 2002 AND I WAS JUST INFORMED BY THE DEALERSHIP THAT 2 MORE ARE BENT. THIS TIME, THEY ARE BENT ON THE "INSIDE." I'M NOT SURE HOW THE INSIDE OF A WHEEL GETS BENT WHICH WOULD SEEM TO INDICATE TO ME THAT THIS WAS NOT THE RESULT OF AN IMPACT. I DID NOT HIT ANYTHING! AK
