STEERING WHEEL/COLUMN IS NOT PARALLEL TO THE DRIVER. IT IS SLANTED SO THAT YOUR LEFT HAND IS FORWARD OF YOUR RIGHT HAND, THEREBY GIVING THE PRECEPTION THAT YOU ARE AIMED/DRIVING TOWARD THE RIGHT SIDE OF THE ROAD. CHECKED ALL CROWN VICTORIA'S ON DEALER LOT AND THEY HAD SIMILAR SETUP AND IN SOME VEHICLES THE SLANT WAS MORE THAN IN OTHERS. ALSO, IN SOME VEHICLES THE DRIVERS SEAT WAS OFF-SET FACING TOWARD THE RIGHT SIDE OF THE CAR. I CONSIDER THIS A SAFETY ISSUE BECAUSE IT COULD LEAD ONE TO OVER STEER OR OVER CORRECT DUE TO THE MIS-PRECEPTION OF WHERE THE VEHICLE IS ACTUALLY BEING GUIDED. SO FAR THE MANUFACTURER HAS NOT ADVISED ME OF WHY THE VEHICLE IS DESIGNED THIS WAY, BUT AGREES
