NO TRANSMISSION SHOP WANTS TO WORK ON IT BECAUSE IT MAY NOT FIX THE PROBLEM. HAS BROKEN TWO ENGINE MOUNTS WHEN PUTTING TRANSMISSION INTO REVERSE OR DRIVE DUE TO THE HARDNESS OF THE OPERATION.
