GAS ODOR IS GONE BUT CAR STILL DIES AT STOPS AND WILL NOT IDLE CORRECTLY. DEALER COULD NOT GIVE ME AN ANSWER FOR THE CAUSES. THIS CAR HAS BEEN TO 3 DIFFERENT DEALERSHIPS AND NONE OF THEM CAN DETERMINE THE CAUSE.*AK
