**THIS IS THE SECOND A6-4.2 THAT HAS THIS PROBLEM. THE CAR DUMPS ALL POWER FROM SLOW SPEEDS. IMAGINE PULLING OUT INTO TRAFFIC FROM A SIDE STREET OR ONRAMP AND TURNING THE IGNITION OFF. AUDI REPLACED MY FIRST A6 BECAUSE OF THIS PROBLEM AND NOW ACCORDING TO THE SERVICE MANAGERS AT THE DEALERSHIP HAS NUMEROUS OTHER 2000 AND 2001 A6'S AND A8'S WITH THE 4.2 ENGINE THAT ARE EXPERIENCING THIS PROBLEM. IT'S ONLY A MATTER OF TIME BEFORE THERE IS GOING TO BE A HORRENDOUS T-BONE OR REAR-END CRASH WITH THESE CARS.
