MY CAR WAS LESS THAN 3 YEARS OLD WHEN THE PROBLEM OCCURRED, SO UNLESS PONTIAC MAKES AN IMPROVEMENT TO THE WINDOW SYSTEM IT WILL CONTINUE TO HAPPEN.
