### NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

FRAME IS CRACKED, TWO BODY SHOPS STATED IT IS A FATIGUE CRACK DUE TO DEFECTIVE METAL USED DURING THE MANUFACTURING OF THE VEHICLE. GMC HAS STATED THEY ARE NOT WILLING TO DO ANYTHING AS THE VEHICLE IS OVER THE WARRANTY, HOWEVER, THE VEHICLE IS ONLY FOUR YEARS OLD AND NEVER BEEN IN A SERIOUS ACCIDENT. BOTH BODY SHOPS, AN INDEPENDENT SHOP AND BOB MAGUIRE CHEVROLET BODY SHOP, HAVE AGREED THIS IS NOT A WEARABLE PART AND NEVER SHOULD HAVE CRACKED. EVEN WITH 500,000 MILES THE FRAME SHOULD NOT CRACK. I TAKE CARE OF MY VEHICLES, OTHERWISE I WOULD NOT BE ABLE TO GET 179,000 MILES ON THE TRUCK. I HAVE A 1991 CHEVROLET SILVERADO AT HOME THAT HAS 286,000+ MILES ON IT AND STILL HAS THE ORIGINAL FRAME
