NISSAN RECOGNIZED EXHAUST MANIFOLD DESIGN DEFECTS LEADING TO MANIFOLD WARPAGE AND REPEATED EXHAUST MANIFOLD BOLT BREAKAGE. EVENTUALLY CAUSING EXHAUST GAS LEAKS AND NOISE PROBLEMS. NISSAN RECOGNIZES DESIGN FAILURE BUT REFUSES TO FIX THE PROBLEM. I'VE SPENT OVER \$1500 REPAIRING EXHAUST MANIFOLDS AND BROKEN EXHAUST MANIFOLD BOLTS. PLEASE HAVE NISSAN RECALL THE FAULTY EXHAUST MANIFOLDS AND BOLTS!
