**NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)**

MARK VIII'S MANUFACTURED DURING THE FIRST MONTHS OF 1997 WERE FITTED WITH A HEADLIGHT ASSEMBLY THAT INCORPORATED AN INTEGRAL HID "LOW BEAM". THIS APPLIANCE WAS OBVIOUSLY INTENDED TO LAST THE LIFE OF THE VEHICLE. ACCESS IS PROVIDED ONLY FOR REPLACEMENT OF THE HALOGEN "HIGH BEAM" BULBS. IN MID-YEAR, FORD REDESIGNED THE HEADLAMP TO ALSO PERMIT REPLACEMENT OF THE HID LIGHT SOURCE. IT NO LONGER SUPPORTS THE EARLIER MODEL. THE ONLY WAY TO RESTORE MINIMALLY LEGAL HEADLIGHT FUNCTION TO MY EARLY-1997 LINCOLN IS REPLACE THE ENTIRE ASSEMBLY WITH A LATE 1997-1998 FIXTURE. MY DEALER ESTIMATES THE COST, INCLUDING LABOR, AT \$1,150 TO \$1,350 PER HEADLAMP. AT THAT PRICE, THE HEADLAMPS REPRESENT 1
