SINCE ABOUT 90,000 MI. THE STEERING POWER ASSIST HAS BEEN ERRATIC. AT LOW SPEEDS, IT FEELS LIKE THERE IS NO POWER ASSIST. JUST RECENTLY, AT ABOUT 135,000, WHILE MAKING SLOW SPEED, RIGHT-HAND TURN, THE STEERING LOCKED ENTIRELY. AT 111,000 MILES, THE DEALER INDICATED THAT THE STEERING RACK WAS FAILING AND WOULD NEED TO BE REPLACED.
