WE BOUGHT THIS PICKUP NEW, HAVE HAD IT IN THE SHOP MANY TIMES FOR THE SAME PROBLEM. IT STALLS ON US AT ANY TIME, THEY HAVE REPLACED PARTS AND REPLACED PARTS. EACH TIME THEY SAY IT IS EITHER THE FUEL INJECTION SYSTEM OR A OIL LEAK. THEY FIX IT AND AGAIN IT HAPPENS. I HAVE NOTIFIED THE MANUFACTORY, AT ONE TIME THEY EXTENDED THE WARRENTY ANOTHER 1200 MILES, BUT OF COURSE THE WARRANTY RAN OUT BEFORE THE TRUCK BROKE DOWN AGAIN. I ASK THEM TO AT LEAST RECALL THE PARTS THAT KEEP GOING OUT OR FIX THE PROBLEM AND PAY AT LEAST HALF OF REPAIRS ON TRUCK, SINCE IT HAS BEEN DOING THE SAME THING OVER AND OVER SINCE THE DAY WE BOUGHT THE TRUCK. ONCE A SERVICE MANAGER TOLD US THAT GM WAS AWARE OF THIS PROBLEM WH
