THE EXHAUST MANIFOLD DEVELOPE 3 CRACKS ALONG THE REDUCER JOINT WHICH REQUIRED REMOVAL AND REWELDED. THE CRACKS STARTED BEFORE THE WARRANTY RAN OUT, BUT I WAS NOT ABLE TO DETERMINE THAT UNTIL I NOTICED AN INCREASE IN ENGINE NOISE AND EXHAUST FUMES IN THE VEHICLE AT WHICH POINT THE WARRENTY JUST RAN OUT DUE TO MILEAGE. THIS COMPONENT SHOULD NOT FAIL THIS FAST.*AK
