A LOCAL NEW YORK STATE AND AAA APPROVED AUTO REPAIR SHOP HAS INFORMATION FROM A NATIONAL DATABASE "ALLDATA", THAT WINDSHIELD WIPERS THAT DO NOT PARK OR SHUT OFF IS A COMMON PROBLEM IN MY PARTICULAR HONDA YEAR AND MODEL. DURING A MINIMAL AMOUNT OF RAIN OR SPLASHING OF WATER FROM OTHER VEHICLES THE CONTINUING WIPERS SMUDGES THE WINDSHIELD CAUSING ALMOST ZERO VISIBILITY. FAULTY OPERATING WINDSHIELD WIPERS/MOTOR WILL NOT PASS NEW YORK STATE INSPECTION, THEREFORE NHTSA SHOULD CONSIDER THIS A SAFETY ISSUE AND PROCEED WITH A RECALL. YAK
