NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

ON MARCH 25, 2002 MY 1997 CHEVY BLAZER SUSTAINED EXTENSIVE DAMAGES FROM AN INTERIOR FIRE. I CONTACTED MY INSURANCE COMPANY AND AN ADJUSTER ASSESSED THE DAMAGES AND REQUESTED A FIRE INSPECTOR EVALUATE THE VEHICLE TO DETERMINE THE CAUSE OF THE FIRE. THE FIRE INSPECTOR, RON CAMPBELL 541-276-7731, DETERMINED THAT THE FIRE STARTED IN THE DRIVER SIDE DOOR AS A RESULT OF AN ELECTRICAL FAILURE. I CONTACTED GENERAL MOTORS REGARDING THIS PROBLEM. THEY DID NOT RESPOND TO MY CONCERNS IN A TIMELY MANNER AND I FELT THAT I HAD NO RECOURSE BUT TO ACCEPT MY INSURANCE COMPANIES SETTLEMENT. MY INSURANCE COMPANY PAID "MARKET VALUE" ON THE VEHICLE, WHICH LEFT ME WITH A SUBSTANTIAL BALANE DUE ON MY VEHICLE.
