WE TAKE THE CAR TO ALBANY FORD FOR EVERY MAJOR SERVICEING. WHEN WE STARTED TO HEAR THE GRINDING NOISE, WE REPORTED IT TO THE SERVICING PERSONEL. THEY FELT IT ODD THAT THE BRAKE PADS AS WELL AS THE ROTORS SHOULD FAIL AT 22000 MILES BUT REFUSED TO REPLACE SAYING THAT THE WARRANTY WILL NOT COVER AS THIS WEAR AND TEAR. ALSO WHEN WE TOOK THE CARE FOR SERVICING AT 5000 MILES, THE BRAKE PADS WERE 10 MM AND WHEN WE TOOK THE CAR BACK AT 14000 MILES, THE PADS WERE 5MM. NOBODY AT THE SERVICE CENTER INFORMED US THAT THE BRAKE PADS WILL NEED TO BE CHANGED SOONER AS THEY ARE WEARING OUT FASTER THAN USUAL. AT THAT TIME THEY DID NOT FEEL IT WAS ODD. THEY REALLY SHOULD HAVE WARNED US, BUT INSTEAD THEY PUT THE
