THE BRAKES PULSATE DRAMATICALLY WHE APPLYING BRAKES STEADILY ABOVE 50MPH. THIS STARTED AT 23,000 MILES,REPORTED AT 30,000 MILES-NO WORK DONE, REPORTED AGAIN AT 32,000 MILES,REFACED BOTH FRONT ROTORS-WARPED. REPORTED SAME PULSATING AT OVER 50 MPH 37,748 MILES-REFACED BOTH FRONT ROTORS. IN CHECKING YOUR WEB SITE THERE ARE DOZENS OF COMPLAINTS ALONG THESE SAME LINES, ABNORMAL VIBRATIONS/ PULSATING FROM BRAKES WHEN BRAKING OVER 50MPH. THIS CONDITION IS EITHER FAULTY MATERIALS AND/OR BAD ENGINEERING. IF NOT CORRECTED BY MFG. SERIOUS ACCIDENTS WILL RESULT WHICH COULD HAVE BEEN AVOIDED. CHRYSLER IS AWARE OF THESE COMPLAINTS AND KNOWS THAT THIS REPEATED PROBLEM IS NOT WITHI
