I HAVE REPLACED MY ROTORS 7 TIMES SINCE PURCHASING MY VEHICLE NEW BACK IN NOVEMBER OF 1996. THE DEALER CONTINUES TO EVADE THE PROBLEM BY REPLACE THE ROTORS EVERY 6 TO 8K MILES. THIS HAS BEEN AN ONGOING PROBLEM WITH MY VEHICLE WHICH THE DEALER IS WELL AWARE OF AND CONTINUES TO DO NOTHING ABOUT IT. I NOW HAVE TO FORCE A RIDE ALONG AND SHOW THEM WHAT THE PROBLEM IS WHEN EXPERIENCING SEVERE VIBRATION BRAKING AT SPEEDS FROM 60 MPH DOWN TO 50 MPH. AGAIN - 7 TIMES THE ROTORS HAVE BEEN REPLACED & STILL FORD HAS NOT GIVEN ME A REASON FOR THE PROBLEM NOR ANY RESOLVE. *AK
