IN JULY 1998, I PURCHASED A 1998 HONDA ACCORD V6 EX. IN FEBRUARY 2000 THE FIRST PROBLEM WITH THE ENGINE CHECK AND EGR DEFECT OCCURRED. THE PROBLEM WAS RESOLVED WITH THE REPLACEMENT OF THE INTAKE MANIFOLD AND REPOSITIONING OF THE PCV VALVE AND HOSE IN ACCORDANCE WITH HONDA RECALL INSTRUCTIONS AND RESETTING THE "CHECK ENGINE" LIGHT INDICATOR AT NO COST TO ME. SERVICE OCCURRED AT DEALER. IN APRIL 2000, THE SECOND PROBLEM WITH THE EGR VALVE AS MANIFESTED BY THE "CHECK ENGINE" LIGHT OCCURRED. THE PROBLEM WAS RESOLVED BY REPLACEMENT OF THE PCV HOSE IN ACCORDANCE WITH HONDA RECALL INSTRUCTIONS AND RESETTING THE "CHECK ENGINE" LIGHT INDICATOR AT NO COST TO ME. SERVICE O
