### NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

**IN REGARDS TO THE EXHAUST MANIFOLD CRACK-- I NOTICED AN EXHAUST SMELL COMING INTO PASSENGER COMPARTMENT AND NOTICED THAT THE ENGINE COMPARTMENT WAS SLIGHTLY LOUDER THAN USUAL. I GOT USED TO THE SMELL BUT NOW I JUST GET HEADACHES. I FIGURED IT NEEDED A NEW EXHAUST MANIFOLD GASKET BUT UPON FURTHER INSPECTION BEFORE BUYING A GASKET, I NOTICED A CRACK IN THE EXHAUST MANIFOLD WHERE THE PIPES COME TOGETHER UNDER THE HEAT SHIELD. THE CRACK LOOKS LIKE IT STEMS OUT IN DIFFERENT WAYS FROM THE OXYGEN SENSOR; IT IS PROBABLY DUE TO POOR DESIGN. I FIGURE THAT IT PROBABLY IMPAIRS THE FUNCTIONALITY OF THE OXYGEN SENSOR THUS ALTERING EMISSIONS. I CONTACTED HONDA AND FOUND OUT THAT A NEW EXH**
