NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

WAS COASTING TO A STOP AT A RED LIGHT. APPLIED BRAKES ON A ROUGH SURFACE AND THE BRAKES FAILED TO BRING VEHICLE TO A STOP. HAD TO USE THE EMERGENCY BRAKE TO HALT THE VEHICLE. THE VEHICLE WOULD NOT STOP EVEN AFTER TRYING TO RE-APPLY THE BRAKES. I HAD TO SHUT OFF VEHICLE AND RESTART THEN THE BRAKES STARTED TO WORK AGAIN. TOOK VEHICLE TO DEALER, AND MECHANICS STATED THAT IT WAS A NORMAL FUNCTION WHEN DRIVING OVER A ROUGH SURFACE FOR THE TIRES TO UNLOCK AS PART OF THE ABS SYSTEM. DEALER DROVE WITH ME TO A GRAVEL PARKING AREA AND SPED VEHICLE AND STEPPED ON BRAKES AND IT DID TO HIM WHAT IT DID TO ME. HE STATED THAT THIS WAS A NORMAL FUNCTION. THIS HAS HAPPENED 8 TIMES THIS YEAR ALONE AND CONTINUES
