IT WAS A CATSTRAUPHIC FAILURE WITH COMPLETE SEPARATION OF THE TIRE WITH NOTHING REMAINING BUT THE TWO PARTIAL SIDEWALLS ALL THE TREAD WAS COMPLETELY GONE AND THE STEEL BELTS WERE COMPLETELY SEVERED WITH NO SHREADS LEFT JUST A CLEAN SEPARATION. I AM WORRIED THAT THESE TIRES ARE UNSAFE AND WILL CAUSE OTHER FAILURES AND ACCIDENTS. THIS COULD HAVE BEEN A VERY SERIOUS ACCIDENT!!!!!! IT WAS A CATSTRAUPHIC FAILURE WITH COMPLETE SEPARATION OF THE TIRE WITH NOTHING REMAINING BUT THE TWO PARTIAL SIDEWALLS ALL THE TREAD WAS COMPLETELY GONE AND THE STEEL BELTS WERE COMPLETELY SEVERED WITH NO SHREDS LEFT JUST A CLEAN SEPARATION. I AM WORRIED THAT THESE TIRES ARE UNSAFE AND WILL CAUSE OTHER FAILURES AND ACCIDENTS. THIS COULD HAVE BEEN A VERY SERIOUS ACCIDENT!!!!!!
