ANY OTHER REPORTS OF PROBLEMS? SOLUTIONS? NOT COMFORTABLE DRIVING THE VEHICLE. HAVE HAD TO TAKE THE SHOULDER SEVERAL TIMES TO AVOID COLLISIONS.
