TIRE AND CAR HAVE BEEN MAINTAINED TO MANUFACTURER SPECS, TIRES HAVE AUTOMATIC TIRE PRESSURE MONITORS. AT ABOUT 11000 MI I NOTICED SOME FEATHERING OF ALL 4 TIRES. I TOOK IT IN AT ABOUT 11700 AND DEALER AGREED ALL 4 TIRES WERE WEARING ABNORMALLY. THEIR FACTORY REP BLAMES GOODYEAR, DELAER STATED 4 WHEEL ALIGNMENT WAS OFF. THEY HAVE DONE NOTHING TO DATE ABOUT THE TIRES PREMATURELY WEARING. AT ABOUT 12600 MI THE TIRE PRESSURE MONITOR INDICATED A SUDDEN DECREASE IN PRESSURE FOR THE RR TIRE. I WAS GOING ABOUT 15 MPH AND WAS NEAR A TIRE SHOP. WHEN I ARRIVED AT THE SHOP, THE TIRE WAS NEARLY FLAT. THEY REPAIRED THE TIRE, BUT INFORMED ME THAT THREE OF THE FOUR TIRES WOULD NOT PASS SAFETY INS
