**INCIDENT 1: THE WINDSHIELD WIPERS HAS FAILED AT LEAST 10 TIMES DURING A TWO YEAR PERIOD. I HAVE REPORTED THE INCIDENT TO THE MANUFACTURER AT LEAST 5 TIMES. SEVERAL OF JAGUAR FIELD SERVICE TECHNICIANS HAS TRIED TO REPAIR THE PROBLEM BUT WITH NO SUCCESS. AFTER EACH ATTEMPTS TO REPAIR THE PROBLEM, I WOULD CHECK THE WINDSHIELD WIPERS FOR THE NEXT COUPLE OF WEEKS TO MAKE SURE EVERYTHING IS OK BUT UNFORTUNATELY THEY FAIL AT THE MOST HAZARDOUS TIMES DURING STORMY, RAINY WEATHER CONDITIONS. INCIDENT 2: I WAS REAR-END IN THE CENTER LANE OF TWO MERGING MAJOR EXPRESSWAYS AND THE ELECTRICAL SYSTEM COMPLETELY FAILED. IT TOOK THE DEALER 3 MONTHS TO GET THE ELECTRICAL SYSTEM STARTED. INC**
