### NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

I WAS DRIVING HOME ON THE INTERSTATE WHEN TRAFFIC STOPPED AHEAD OF ME. IT WAS RAINING PRETTY HARD AND I WAS NOT ABLE TO STOP AND I HIT A MINIVAN THAT WAS IN FRONT OF ME. (THERE WERE 40 - 50 OTHER VEHICLES INVOLVED IN THIS INCIDENT, BUT MY PIECE OF THE GREATER WRECK ONLY INVOLVED MYSELF AND THE MINIVAN.) I DO NOT KNOW HOW FAST I WAS GOING WHEN I MADE CONTACT, BUT IT WAS FAST ENOUGH TO CAUSE \$16,000 OF DAMAGE TO THE FRONT END OF MY TRUCK. THE IMPACT MOSTLY WENT ABOVE THE BUMPER, PUSHING THE GRILL INTO THE FRONT OF THE ENGINE CAUSING EVERYTHING IN FRONT OF THE ENGINE TO BE REPLACED ALONG WITH REPLACEMENT OF THE MOTOR AND TRANSMISSION MOUNTS. NEITHER THE DRIVER OR PASSANGER AIRBAG DEPLOYED. I WAS
