### NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

THE 1998 DODGE DURANGO REAR DIFFERENTIAL UNIT SEIZED AND FAILED ON A MAJOR HIGHWAY . I WAS UNABLE TO MOVE THE VEHICLE AND CAUSED US TO IMMEDIATELY EXIT THE VEHICLE TO AVOID ON COMING TRAFFIC. THE VEHICLE WAS TOWED TO THE DEALERSHIP WHERE I WAS TOLD THAT THE REAR DIFFERENTIAL WAS IN PIECES. THE DEALER DENIED TO ABSORB THE REPAIR COST FOR THEY SAID IT WAS OUT OF WARRANTY. I APPEALED TO THE CUSTOMER SERVICE REPRESENTATIVE WHO DENIED THE CLAIM. I CALLED AN INDEPENDENT INSURANCE TECH REP AND HE CONCLUDED IT WAS A SERIOUS DESIGN FLAW. IN MY PERSONAL OPINION I FEEL DODGE SHOULD INSPECT AND REPAIR THESE VEHICLES. \*AK
