THE CAR EXHIBITS A CONDITION WHEN THE STEERING WHEEL SHAKES BACK AND FORTH AS WELL AS HAVING A PULSATING PEDAL WHEN THE BRAKES WERE APPLIED. AT THE FIRST OCCURANCE, 3 MONTHS AFTER PURCHASING THE CAR, I HAD THE ROTORS TURNED AND INSTALLED NEW FRONT BRAKE PADS (THE ROTORS WERE NOT WORN, JUST SEVERELY WARPED). MONTHS LATER THE SAME OCCURANCE. AT THIS JUNCTURE, I REPLACED THE ROTORS WITH NEW PARTS, AND WENT TO PREMIUM CERAMIC PADS. NOW BARELY ONE MONTH LATER, THE AFOREMENTIONED EFFECTS HAVE REOCCURED AND THE NEW ROTORS ARE AGAIN WARPED. REALLY LOVE THE CAR, BUT WANT THIS FIXED AS IT FEELS VERY SCAREY TO DRIVE.*JB
