TRANSMISSION FAILING. CLUTCH ENGAGES LATE AND SUDDENLY: ENGINE REVS AS GAS IS APPLIED BUT CLUTCH DOESN'T ENGAGE, THEN CLUTCH ENGAGES SUDDENLY, CAUSING CAR TO JERK FORWARD HARD. THIS IS DANGEROUS--CAN'T PULL OUT INTO TRAFFIC, BECAUSE I DON'T KNOW IF CAR WILL ACTUALLY GO WHEN I STEP ON THE GAS, AND CAR COASTS AS TRANSMISSION TRIES (BUT FAILS) TO SHIFT BETWEEN E.G. 1ST AND 2ND. PLEASE REQUIRE A RECALL ON THIS--MANY PEOPLE HAVE REPORTED THE SAME PROBLEM IN AUTO NEWSGROUPS ON THE INTERNET. THIS IS CLEARLY A MANUFACTURING DEFECT, AND A POTENTIALLY SERIOUS SAFETY PROBLEM AS WELL.'AK
