TRANSMISSION PROBLEM HAS BEEN ANALYZED SEVERAL TIMES BY BOTH FORD DEALER AND OTHER SHOPS. THEY FEEL SOLENOIDS INTERNALLY HAVE FAILED AND TRANSMISSION MUST BE REBUILT/REPLACED. VEHICLE DOES NOT SHIFT PROPERLY, WILL NOT GO INTO OVERDRIVE (4TH GEAR), LOSS OF CRUISE CONTROL. WHAT SHIFTING REMAINS IS ERRATIC. SPEEDOMETER GEAR DRIVE SHEARED OFF AND WAS REPLACED BEFORE FULL EXTENT OF PROBLEM BECAME KNOWN. IN READING ON THE NET ABOUT OTHER PEOPLE WITH SAME PROBLEM, APPEARS SOLENOID FAILURE IN THIS TRANSMISSION IS COMMON AND PREMATURE.*AK
