NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

BRAKES FAILED ON TWO SEPARATE OCCASIONS. THE FIRST FAILURE OCCURRED AT APPRX. 9,000 MILES AND THE SECOND OCCURRED AT APPROX. 25,000 MILES. THE DEALER DID A COMPLETE OVERHAUL TO THE BRAKING SYSTEM AT 10,000 MILES HOWEVER WOULD NOT FIX THEM FREE OF CHARGE ON THE SECOND VISIT. THE REPLACEMENT PARTS WERE STILL UNDER WARRANTY BUT THE DEALER DID NOT HONOR THE WARRANTY. BEING A LOYAL GM CUSTOMER I EXPECTED A LOT MORE FROM THE DEALER AND GM, THEY SHOULD STAND BY THEIR PRODUCTS, ESPECIALLY WHEN THEY ARE SUBSTANDARD. THERE IS NO REASON THAT THE BRAKES SHOULD HAVE FAILED TWICE IN LESS THAN 25,000 MILES. I CAN'T SAY ANYTHING POSITIVE ABOUT MY EXPERIENCE WITH GM AND BILL RAPP PONTIA
