WHEN PULLING INTO A PARKING SPOT THE VAN STALLED AND WOULDNT RESTART. IT SEEMED THE BATTERY WAS TOTALLY DRAINED SO I WENT TO REPLACE IT AND FOUND THAT THE BATTERY CABLES WERE SCORCHING HOT. WHEN I INSTALLED THE REPLACEMENT BATTERY IT WAS AT NIGHTR SO I SAW SPARKS DOWN ON THE LOWER PORTION TO THE BATTERY HARNESS. I THEN HAD THE VAN TOWED INTO THE DEALERSHIP AND THEY INTIALLY FOUND NO DEFECTS, TOLD ME THE BATTERY WASNT INSTALLED PROPERLY.
