WHILE DRIVING TO WORK I HEARD A CLUNKING SOUND COMING FROM MY STEERING WHEEL AS I WAS GOING OVER THE FREEWAY OVERPASS THE STEERING WHEEL STUCK, I YANKED ON IT AS HARD AS I COULD UNTIL IT MOVED.
