THE PROBLEM IS WITH THE SENSOR INSIDE THE BELT THAT TURNS ON THE SEAT BELT LIGHT. IT HANGS UP AND YOU CANNOT GET OUT! I HAVE STARTED TO CARRY A KNIFE JUST IN CASE I HAVE TO CUT THE BELT TO GET OUT. THE LONGEST I'VE FOUGHT WITH IT IS 15MIN. ITS NO FUN AND I THINK NISSAN HAS A REAL PROBLEM. I AM REAL SICK OF FIGHTING TO GET OUT OF MY TRUCK.
