I BOUGHT MOTORCYCLE USED JUST RECENTLY FROM A PRIVATE OWNER. WHEN TEMPERATURES STARTED REACHING UP TO 90 DEGREES AND ABOVE, THE THROTTLE BECAME VERY HESITANT WHEN DOING A SLOW ACCELERATION. THE VEHICLE WOULD HESITATE, THEN SURGE FORWARD A COUPLE TIMES.. EVEN WHEN HOLDING THE THROTTLE CONSTANT. THIS HAS PUT ME IN DANGEROUS SITUATIONS ON SEVERAL OCCASIONS LIKE WHEN MAKING TURNS FROM A STOP AND THE BIKE DOES NOT KEEP THE CENTRIFUGAL FORCE TO HOLD THE BIKE UP BECAUSE IT HESITATES, OR WHEN ACCELERATING IN RUSH HOUR TRAFFIC OR IN BUSY CITY STREETS (I LIVE IN THE WASHINGTON DC METRO AREA). THIS IS 800 POUND VEHICLE ON 2-WHEELS. ALONG WITH A RIDER, PASSENGER, AND LUG
