I RECEIVED A RECALL NOTICE VIA MAIL & BROUGHT MY CAR TO THE LOCAL MITSUBISHI DEALER. THEY DID SOME WORK ON THE AUTOMATIC SHOULDER BELT. I DO NOT BELIEVE THAT ENOUGH WAS DONE. NOW THEY REFUSE TO DO ANY MORE "GOODWILL" REPAIRS AT NO CHARGE. THIS IS MY SAFETY AT RISK. I EVEN TOOK IT AND PAID FOR IT MYSELF TO ANOTHER SERVICE CENTER AFTER ANOTHER FAILURE. I HAVE WRITTEN REPORTS OF THIS. I ALSO HAVE COPIES OF WHAT I WAS TOLD IS A "SILENT RECALL" WHERE THE OWNER IS NOT NOTIFIED. KEEP IN MIND, BEFORE I TOOK IT FOR SERVICE TO THE FIRST PLACE, THERE WAS NEVER A PROBLEM. ALL THE PROBLEMS HAVE DEVELOPED AFTER THE DEALERSHIP WORKED ON THE CAR. THIS HAS BEEN EXTREMELY FRUSTRATING TO ME AND A LONG PRO
