**THE SPEED CONTROL DISCONNECTS WHEN THE WINDSHIELD WIPERS ARE TURNED ON DURING RAINY CONDITIONS. THIS REPEATEDLY HAPPEND OVER A FOUR DAY PERIOD WHEN DRIVING IN THE RAIN THROUGH THE MIDWEST. THIS PROBLEM HAS NEVER OCCURRED WHEN THE WIPERS ARE USED TO SIMPLY CLEAN THE WINDSHIELD DURING DRY CONDITIONS. \*AK**
