AS I WAS DRIVING ON AN INTERSTATE HIGHWAY, I ATTEMPTED TO PASS ANOTHER VEHICLE. THE OTHER VEHICLE SPED UP; I SLOWED; HE SLOWED; OBVIOUSLY A GAME OF SOME KIND WAS BEING PLAYED THAT I WANTED NO PART OF, SO I TRIED TO GET AWAY AND WHEN I HIT 85MPH, MY VEHICLE CEASED TO ACCELERATE AND BEGAN ACTING LIKE IT WAS STARVED FOR GAS.
