IT PROCEEDED TO GET MORE & MORE SLUGGISH. I DIDN'T DRIVE THE CAR THE NEXT DAY AT ALL, BUT THE NEXT DAY, HOWEVER, I HAD TO DRIVE IT. I DROVE IT APPROXIMATELY 20 MILES, & THEN I CALLED MY HUSBAND TO FOLLOW ME HOME AFTERWARDS. I WAS AFRAID TO DRIVE IT. IT WOULDN'T ACCELERATE OFF THE LIGHTS, & I WAS AFRAID THE TRANSMISSION WAS ABOUT TO DROP-OUT. I COULDN'T GET IT ABOVE 40 MPH, & IT KEPT STALLING.
