I CONTINUE TO HAVE A PROBLEM WITH MY VEHICLE STALLING FOR NO APPARENT REASON. IT HAPPENED TWICE IN OCTOBER 2001. THE FIRST TIME IT HAPPENED I CALLED THE DEALERSHIP TO SEE IF THERE WAS A PROBLEM WITH THE ESCAPE. I WAS TOLD THERE WAS NO PROBLEM & THERE WAS NOTHING WRONG WITH MY VEHICLE BUT CALL IF IT HAPPENS AGAIN. MY VEHICLE STALLED THE NEXT DAY. I TOOK THE VEHICLE TO THE DEALERSHIP BUT THEY WERE UNABLE TO DUPLICATE THE STALL. THEY CONTACTED THEIR REPAIR HOTLINE FOR SUGGESTIONS. THERE WAS APPARENTLY NO REAL ANSWER BUT IT WAS SUGGESTED TO REPLACE A VARIETY OF PARTS. MY VEHICLE HAD NO PROBLEMS UNTIL 06/25/02 WHEN IT STALLED AGAIN FOR NO REASON. THIS IS A SERIOUS SAFETY ISSUE.
