FORD IS KNOWINGLY SELLING A DEFECTIVE ENGINE IN THEIR FORD RANGER. MY FACTORY ORDERED TRUCK HAS WHAT COULD BE DESCRIBED AS A SEVERE, CONSTANT "ROUGH IDLE". I HAVE HAD IT BACK TO THE DEALER A NUMBER OF TIMES (THE FIRST TIME WAS 2 DAYS AFTER I PURCHASED IT). FORD HAS SENT THEIR DISTRICT ENGINEER TO LOOK AT THIS ISSUE. HE PERFORMED A "G-FORCE" TEST WHICH REGISTERED 0.6. FORD SERVICE AGREES THAT IT HAS THIS ISSUE. FORD'S STANCE IS THAT ALL 2002 RANGERS HAVE THIS ISSUE (NUISANCE IS THE WORD THEY USED) AND THEY ARE NOT GOING TO DO ANYTHING TO "FIX" IT. THE ENGINEER TOLD ME THAT FORD IMPLEMENTED "SOFTER" MOTOR MOUNTS TO TRY AND ALLIEVIATE THIS ISSUE WHICH MY TRUCK ALREADY HAD. SO FORD IS VERY AWARE OF THIS
