I HAVE MADE REPEATED COMPLAINTS TO VICTORY NISSAN IN RICHMOND VIRGINIA ABOUT THIS VEHICLE. I HAVE ALSO CONTACTED NISSAN DIRECTLY AND THEY NEVER EVEN ADDRESSED THE LETTER I SENT THEM DECEMBER, 2001. MY TRUCK HAS EXPERIENCED DRIVE TRAIN VIBRATIONS SINCE I PURCHASED IT AT 6900 MILES. DESPITE THE DOZENS OF TECHNICAL BULLETINS ADDRESSING THIS PROBLEM, I HAVE REPEATEDLY BEEN TOLD THAT NOTHING CAN BE DONE TO HELP MY VEHICLE. WHEN THE CENTER BEARING WAS FINALLY DISCOVERED TO BE BAD, THE DEALERSHIP REPLACED IT AND THE SHIMMY I ORIGINALLY HAD WAS THEN MAGNIFIED TO AN ATROCIOUS HARMONIC HUM. RIDING IN MY TRUCK IS LIKING RIDING ON A WASHING MACHINE. I HAVE BEEN ADVISED BY THE DEALERSHIP NOT TO HAUL LOAD.
