I HAVE THREE SEPARATE INCIDENTS. FIRST OCCURRING IN 1997 WHILE TAKING MY GRANDSON TO HIGH SCHOOL: WHILE COMPLETING THE TURN INTO THE PARKING LOT AT HIS SCHOOL, MY 1986 THUNDERBIRD SUDDENLY SURGED AS IF I HAD FULLY PRESSED THE ACCELERATOR TO THE FLOOR. FORTUNATELY, I WAS FINALLY ABLE TO REGAIN CONTROL AND NEITHER OF US WERE INJURED NOR WAS THERE ANY PROPERTY DAMAGE. INCIDENT#2- WHILE RETURNING HOME FROM SHOPPING, I WAS DRIVING IN THE LANE CLOSEST TO THE CURB ON A 4 LANE STREET WHEN SUDDENLY, AGAIN, MY CAR ACCELERATED AND PULLED TO THE RIGHT WHERE I JUST BARELY GLANCED OFF A SMALL STATIONERY POLL THAT WAS POSITIONED BASICALLY ON THE SIDEWALK. AGAIN, THANK GOD, NO
