NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

THE AIR BAG LIGHT CAME ON WHEN VEHICLE WAS STARTED AFTER BEING UNUSED FOR 1-2 WEEKS. I TOOK THE CAR IN FOR SERVICE AND WAS TOLD OF A RECALL FOR INADVERTANT AIR BAG DEPLOYMENT , SO I AUTHORIZED THE DEALER TO DO THE RECALL. THE DEALER THEN CALLED AND SAID THERE WAS A CODE IN THE COMPUTER TELLING THE AIR BAGS TO DEPLOY AND THE COMPUTER NEEDED TO BE REPLACED BEFORE THE CAR SHOULD BE DRIVEN TO PREVENT A POSSIBLE DEPLOYMENT OF THE AIRBAGS. I WAS TOLD THAT EVEN THOUGH THIS FIT THE RECALL FOR INADVERTANT AIRBAG DEPLOYMENT IT WAS A DIFFERENT PROBLEM AND WOULD COST AROUND \$400 TO REPAIR. I THEN ASKED THE SERVICE MANAGER TO TRY AND GET THIS FIXED BY CHEVROLET AND WAS TOLD THAT THEY
