WHEN THIS SWITCH FAILS IT CAUSES NUMEROUS SEEMINGLY UNRELATED SYSTEM FAILURES IN THE CAR, MAKING DIAGNOSIS DIFFICULT AND TIME-CONSUMING. THE DRL SYSTEM LOSES POWER SO THAT THE HEADLIGHTS WILL NOT FUNCTION AT ALL IN THE DAYTIME AS GM INTENDED AND WILL GO OUT PERIODICALLY AT NIGHT WITHOUT WARNING UNLESS TURNED ON MANUALLY WITH THE HEADLIGHT SWITCH. THE HVAC SYSTEM GENERALLY WILL NOT FUNCTION DUE TO THIS FAILURE; ALTHOUGH OCCASIONALLY IT WILL WORK WITH THE FAN ON HIGH SPEED. THE ELECTRIC REAR WINDOW DEFOGGER WILL NOT FUNCTION AT ALL DUE TO THIS FAILURE. ALL OF THESE SAFETY-RELATED SYSTEMS PULL THEIR POWER FROM THIS POORLY DESIGNED AND INADEQUATELY SIZED COMPONENT. UPON DISASSEMBLY
