WINDSHIELD WIPERS WORK ONLY INTERMITTENTLY. VEHICLE TAKEN TO DEALER. WIPERS STOP WORKING RANDOMLY AND WILL NOT BEGIN AGAIN UNTIL VEHICLE ENGINE HAS COOLED. MANY TIMES IT LEFT ME STRANDED AND UNABLE TO PROCEED SAFELY. I EXPERIENCED THE EXACT SAME PROBLEM WITH A PREVIOUS VEHICLE (1994 CHEVY ASTRA VAN). AFTER TALKING WITH SEVERAL OTHER PEOPLE WITH SIMILAR VEHICLES, THEY ALSO EXPERIENCED THE SAME PROBLEM. EACH HAD TO PAY CHEVROLET APPROX. \$90.00 TO HAVE THE CIRCUIT BOARD REPLACED ON.
