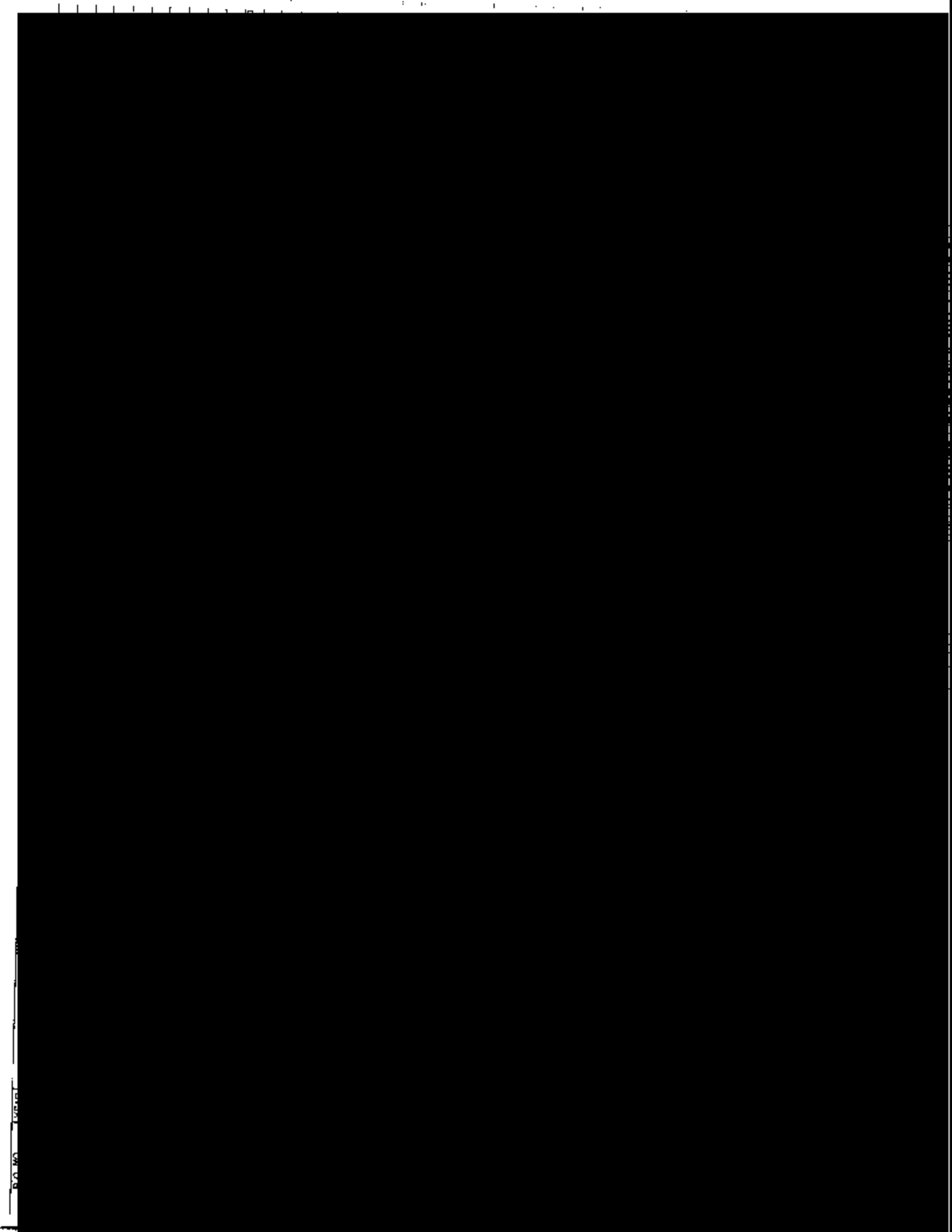

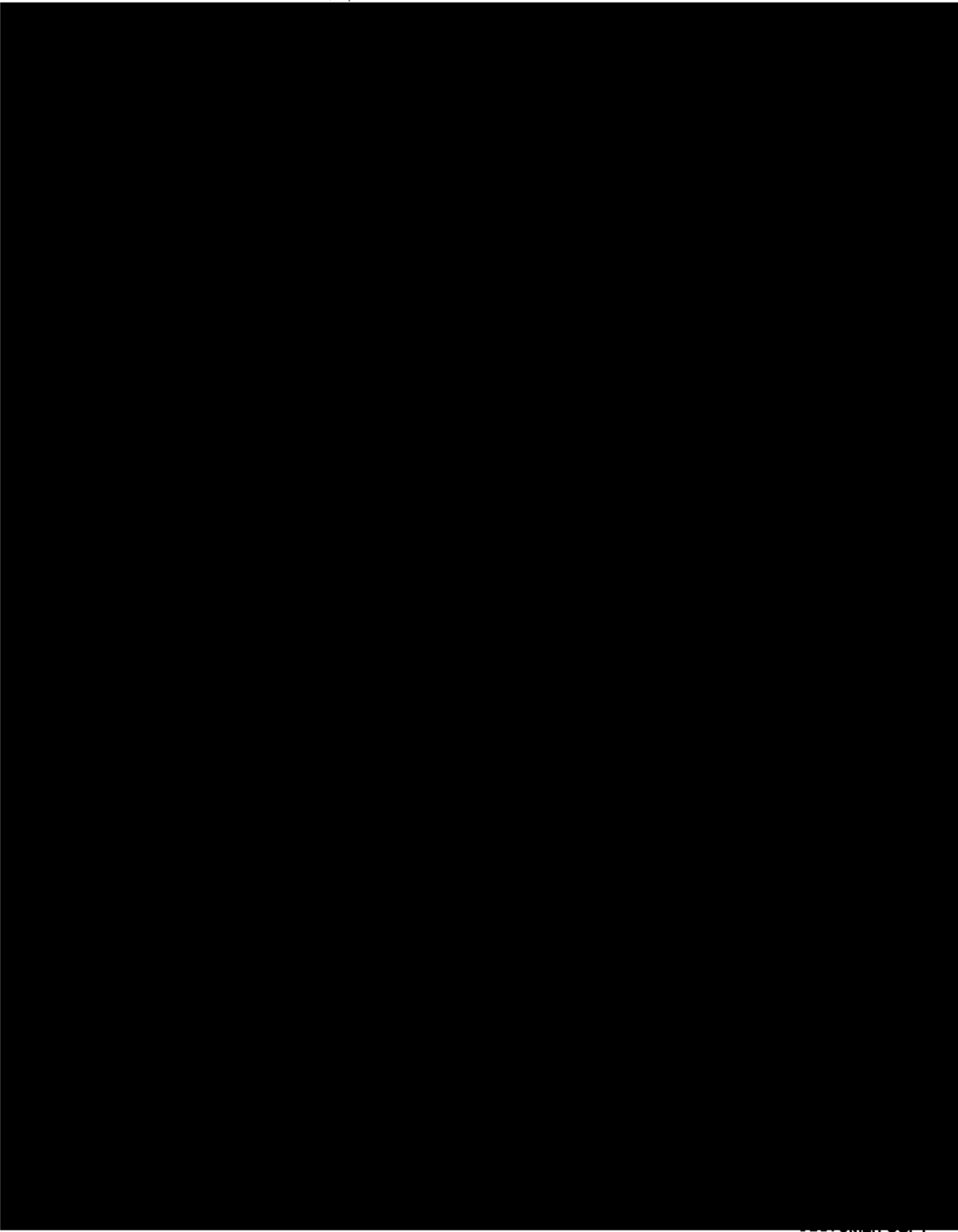
Upon removal of brakes both pads were completely worn away, while the outer pad showed no sign of wear indicating a caliper problem.

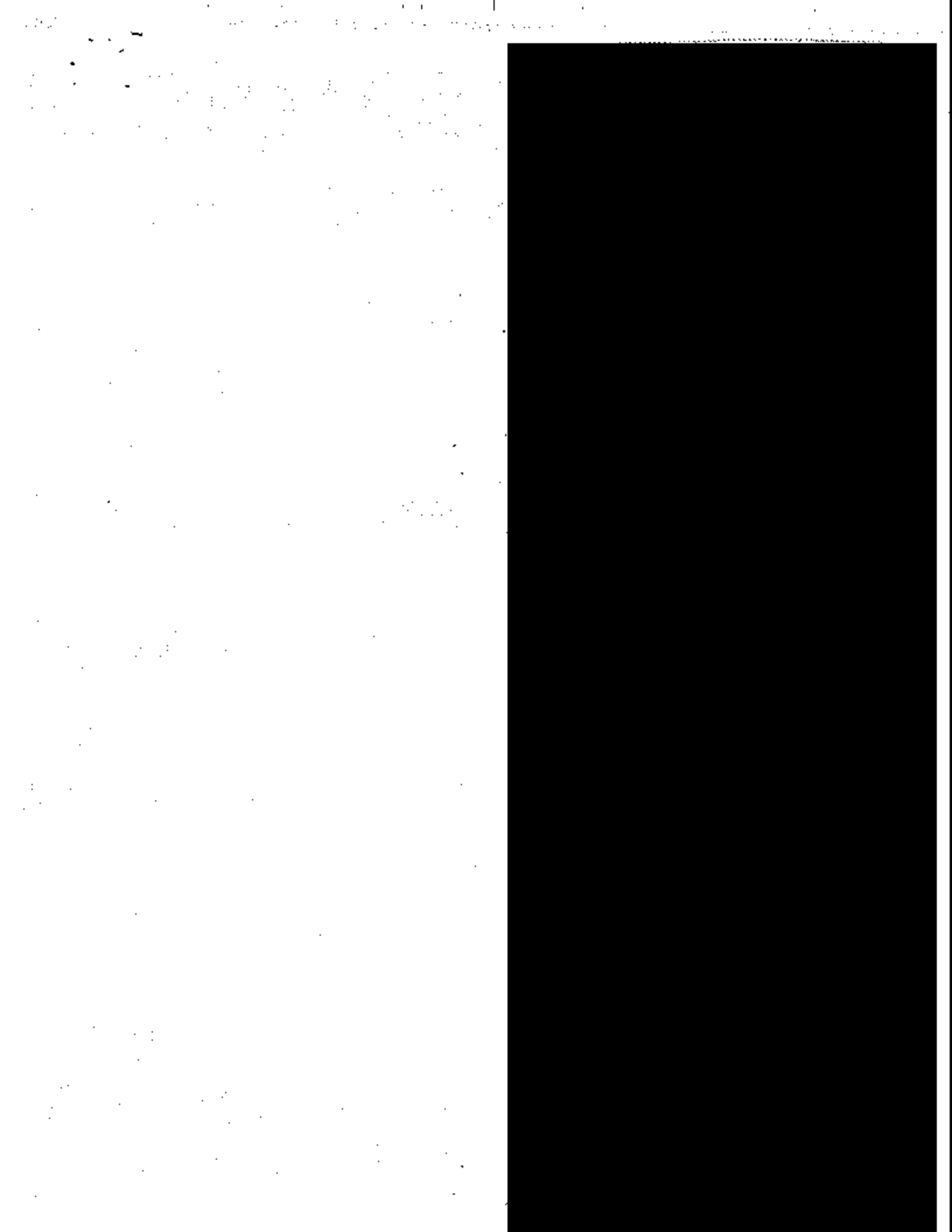
